**Cancellation Policy:** A guarantee for the group package is required for group events. **Maximum Guests per Unit & Grounds:** For the privacy and comfort of our guests we limit the maximum number of guests for each cabin and on the grounds. The maximum number for each unit or less is permitted. Some exceptions are made for infants and small children on a case-by-case basis. A limited number of day-visiting guests are allowed for a per guest fee.

**Non-Smoking:** All cabins and cottages are non-smoking inside. Fine for non-compliance is \$125 per unit. Smoking is allowed outside. Please deposit butts in the receptacles, NOT on the grounds.
